SUBJECT: Rental Rate Adjustment

State Fleet Services has reviewed the rental rates and adjusted them to reflect the most recent cost of operation. Please review the entire document to see how the changes will affect your agency. The attached rental rates are effective **April 1, 2024**.

Here are some explanations of what costs the fleet has experienced. A few vehicle groups saw increases in repair costs which impacts the operating rate for those groups. Some groups saw a change in the depreciation due to new purchases and gains/losses on sale. All these factors have a direct impact on the overall rental rate for each vehicle group.

Please remind your users it is important that scheduled maintenance is completed on all fleet vehicles to ensure a safe and well running fleet. Last, we encourage the use of motor pool fueling locations whenever possible to help lower operational costs.
