Outstanding Group Teaching Award recognizes faculty who demonstrate a strong commitment to teaching and student success, and who have worked together collaboratively to improve student learning.

The Outstanding Faculty Collaborative Research Award recognizes collaborative faculty teams for their accomplishments in research, scholarship and creative activities.

Outstanding Team Recognition Award recognizes a group or team of staff and faculty (and possibly students) who exemplify cooperation, collaboration and open communication. The group receiving the award must be comprised of supportive team players who worked in partnership on a project that significantly advanced departmental goals and/or University Mission.

Criteria

- Odney: Outstanding teaching, commitment to student learning, and contributions to education
- Peltier: Contributions to innovative pedagogy to enhance learning and educational experiences of students
- Phi Kappa Phi Faculty Lectureship Award: Outstanding scholarship and ability to effectively present research to a broad community
- Faculty Lectureship: Sustained record of distinction in teaching and research, and exceptional contributions to service
- Waldron: Outstanding scholarly achievements and significant contributions to research
- Chamber of Commerce Distinguished Faculty Award: Substantial service contributions to the community and the region, and commitment to excellence
- Excellence in Mentoring Award: Outstanding efforts to encourage students, faculty, and staff to reach their full potential
- Service Learning Award: Commitment to course-base community service experiences that provide substantial learning opportunities for students
- Outstanding Faculty Advisor Award: Exceptional advising skills and commitment to help students reach their full potential
- Outstanding Professional Advisor Award: Exceptional advising skills and commitment to help students reach their full potential
- University Distinguished Professor: Outstanding academic record comprising sustained, high-quality and appropriately balanced contributions to all three areas of research/creative activity, instruction and service. In addition, a University Distinguished Professor is expected to demonstrate the highest standards of good character, academic integrity and university leadership, and to demonstrate a significant impact beyond their own individual program.
- Endowed Professorships: For a balanced academic record demonstrating excellence in teaching, research, and service.
