 - Include case studies earlier.

- Ways to 'derail the train' and less time on 'keeping the train on the track' and an opportunity to discuss case studies as well as experiences already gained by faculty who have PTE committee experience.
- <u>Could</u> have been 90 min. First 20 min. cut to 5. Many generalities discussed too much. Pay attention to value of items discussed Impact Factor (e.g.) not needed.
- Look to implementing a standard format for CVs.
- List of possible biases.
- Don't spend so much time on introductory/basic material that longtime PTE members would already know –
 or give a more streamlined workshop for veteran PTE members.
- I still do not understand why folks who get extensions don't have to produce more.
- I have chaired department and college committees for years, so familiar.
- Time management.
