Leap Lab Renovation Grant:

- Does the Co-PI have to be tenure track woman faculty as well? Is that for priority list or criteria? For this grant only or all grants?
- Could the renovations include cabinet, counter, and hood?

Climate and Gender Equality Grant:

• Does this grant (Climate and Gender Equality) require matching funds?
