

SURFACE MINING REPORT FOR MINERALS OTHER THAN COAL SUMMARY

Law, which requires any person conducting surface mining operations for minerals other than coal, to comply with the reporting requirements of Chapter 38-16 (North Dakota Century Code). The North Dakota State Soil Conservation Committee was designated by the Legislature to administer the Surface Mining Reports

combined mining operations to report. Minerals included are: cement rock, clay, gravel, limestone, manganese, molybdenum, peat, potash, pumicite, salt, sand, scoria, sodium sulfate, stone, zeolite, or other minerals, but does not include coal. The Law requires any person conducting surface mining operations for minerals, other than coal, who, within one calendar year, removes 10,000 cubic yards or more of earthen material or products, including overburden, or affects one-half acre or more, in
