

Cancellation of Registration / Withdrawing to Zero Credits

Please read the following information regarding the potential impacts of cancelling your registration or withdrawing to zero credits.

ACADEMIC RECORDS INFORMATION

Withdrawing to Zero Credits

Campus Connection does not allow you to drop your last or only class. Students who do not have grades posted to their transcript and who wish to withdraw from courses in a current or future semester must complete the **Cancellation of Registration/Withdrawing to Zero Credits** form (*on next page*). Students who have graded courses on their transcript for the current semester are not eligible for a withdraw from these courses. Remaining courses must be dropped in accordance with published deadlines using Campus Connection without refund. Failure to initiate the withdrawal process may result in failing grades and possible financial obligations.

Refer to the University's official dates and deadlines (www.ndsu.edu/registrar/dates) for the last day to withdraw. Withdrawals after this date are not processed without evidence of compelling circumstances beyond the student's control. Late withdrawal requests require students to complete and submit an **Appeal for Exception to Academic Regulations** form (www.ndsu.edu/registrar/forms/acadappeal).

Impact on Coursework

Courses withdrawn after the last day for No Record Drop for a term will be recorded with a "W".

Courses taken via collaborative registration with other NDUS institutions, Tri-College consortium, cooperative education/internships, or short courses that have already concluded or have been graded for the term will also be automatically withdrawn from your record.

Non-degree credit Professional Development courses (e.g., EDUC 2000) **WILL REMAIN** on your Continuing Education record. To withdraw from Continuing Education/Professional Development courses, contact the Office of Teaching and Learning (www.ndsu.edu/otl, 314 Family Life Center, 701-231-7015, ndsu.otl@ndsu.edu).

TUITION & FEES REFUND INFORMATION

Refunds for withdrawals to zero credits are prorated based on the length of course and the date of withdrawal. The term withdrawal refund schedule is available online (www.ndsu.edu/onestop/accounts/dropping_withdrawing).

Financial Aid Impact

Financial aid recipients may have all or a portion of their financial aid returned based on the date of withdrawal which could result in a balance owed to the University. Your withdrawal may affect your future eligibility for financial aid if you do not complete 67% of cumulative credit hours attempted whether or not you are currently a financial aid recipient.
