The meeting was focused on Parking

Bruce Bollinger (VP for Finance and Administration), Michael Ellingson (Director of Facilities Management) and Robert Lynch (Parking and Transportation) presented the fowling information.

Motorcycles no longer need a permit. They will still need to park in designated areas. Parking did this because the enforcement was difficult and was not cost effective.

Because of an agreement that was entered in to by the previous administration, the City of Fargo oversees parking enforcement on campus. The City of Fargo recently added an appeal process with a municipal court judge Enforcement has dropped, because of the unique changes on campus, including guests, one day passes, career center, admissions, and prospective students not knowing the campus and how parking enforcement works. Parking has avoided having to be involved in a municipal court appeal to date.

The Master Plan that was completed in 2010 gave parking a list of the conditions of our parking lots on campus. Many were labeled Very Pour and Pour. Below is the list of very poor and poor lots and the prospective year of replacement and current cost of replacement depending on funding. Bruce Bollinger told the committee that the Parking fund will not run a deficit.

Under the previous administration the fund was not used for covering unrelated costs, but because of the audit, Parking is now responsible for paying for more items. Snow removal and Transit are two big items that were added.

Parking pays The Fargodome for use of their parking lots. The committee passed a motion to raise the fee to \$60 to cover this cost.

We were informed that our parking is lower than other peer universities. UND's parking fee is also quite a bit higher.

Without an increase in permits the fund would run a deficit in FY 12. The committee passed a motion to raise the parking fee \$30 to try and keep the fund from running a deficit. This will allow for many needed improvements.

A prorated parking fee was discussed. Distance from your place of work and faculty would've been too complicated. Faculty having a higher rate than staff was also discussed, but this would involve HR and could possibly infringe on employee personal data.

A student fee is being looked into for covering the transit costs. Rob is planned to bring this to the Student Senate next year. He is expecting some resistance because of the tuition and fee increase in the past year.

This summer and into the future you will begin to see many improvements to the parking lots and streets.
