Memorandum of Understanding

This memorandum outlines the terms under which North Dakota State University (hereafter referred to as NDSU) participates in the Regent's University London (hereafter referred to as RUL) programme.

Regent's University London is one of the UK's most respected private universities and comprises

Regent's American College London*

Regent's Business School London

Regent's School of Drama, Film & Media

Regent's School of Fashion & Design (formerly AIU London)

Regent's School of Psychotherapy & Psychology

Regent's Institute of Languages & Culture

European Business School London

*Courses at Regent's American College London are validated through Webster University, Missouri, which is accredited by the North Central Association of Colleges and Secondary Schools.

This memorandum takes effect from the most current sign date and shall remain in operation unless terminated in writing by either party. Either party hereto, may at any time during the term of this Agreement, with or without cause, terminate this agreement upon one-hundred and eighty (180) days prior written notice to the other party. Upon written consent by both parties, students who are enrolled in the RUL programmes prior to the notification of termination shall be permitted to complete the educational programme.

Regent's University London will:

- Publish the academic programme, calendar and fees for each semester including the summer 1. terms in good time.
- Exercise quality control of the programmes in consultation with affiliated colleges and 2. universities.
- Appoint highly qualified faculty to deliver the courses. 3.
- Service the academic programme with appropriate learning resources. 4.
- Provide a co-curricular programme through the department of Student Services. 5.
- Provide health care through the National Health Service. No charges will be imposed by RUL however UK state regulations may apply at point of delivery.
- Provide a room and board package for all participants. 7.



- 8. Announce in October the tuition, room and board fees for the following academic year.
- 9. Invoice Affiliates on May 1st and November 1st each year.
- 10. Report final grades back to the home campuses for students to receive transfer credit.

North Dakota State University will:

- 1. Award its own credit for courses successfully completed at RUL.
- 2. Select students in good academic standing and of adequate maturity to successfully participate in the programme.
- 3. Exercise the right to appoint a professor to accompany the students and to join the teaching faculty at RUL (as and when appropriate for the Affiliate). Affiliate may pay the London Cost of Living Allowance to such an accompanying faculty member.
- Contribute to the development of the programme through participation in the annual 4. Affiliates' Forum. Affiliates may send an institution representative to participate in the annual Affiliates' Forum held during the RUL International Partner's Conference event early in January of each year.
- 5. Exercise the right to publicize the programme in its literature.
- Benefit from the tuition fee credit arrangements shown on the accompanying fees 6.
- 7. Forward all fees to Regent's according to the payment schedule.

The persons executing this Agreement on behalf of North Dakota State University and Regent's University London represent that they are duly authorized to do so.
